



## **TERMS & CONDITIONS – WEDDING EVENT BOOKING**

### **1. Room Reservation**

Room bookings shall be confirmed based on the final room count shared at least three (3) months prior to the event. Any rooms not utilised shall be treated as no-shows and charged accordingly.

### **2. Room Rates & Inclusions**

All room rates are inclusive of applicable taxes and standard amenities such as welcome drinks, air-conditioned rooms, tea/coffee makers, packaged drinking water, electronic safes, television, buffet breakfast, and use of the swimming pool as per hotel timings.

Food menus and pricing shall be as mutually agreed in writing. Buffet rates include food, service staff, standard seating arrangements, table linen, and chair covers. Beverages will be charged separately based on actual consumption.

**Time:** 8.30 pm to 10.00 pm

**Rate: Rs 1650/- inclusive of all applicable taxes**

#### **Starters:**

**Time:** 7.00 pm to 8.00 pm

**Rate: Rs 750/- per head**

#### **Menu:**

1 Chinese veg starter/1 Tandoori veg starter/1 Non Veg chinese starter/1 Non Veg Tandoori starter

#### **Vegetarian Dinner:**

**Time:** 8.30 pm to 10.00 pm

**Rate: Rs 1550/- inclusive of all applicable taxes**

Beverages are charged as per consumption.

#### **4. Venue Usage Charges**

A venue usage charge of Rs. 85,000/- per day (inclusive of applicable taxes) shall be applicable for the event space.

#### **5. Damage & Loss Policy**

The hotel shall not be responsible for loss or theft of guest valuables. Guests are advised to use the electronic safes provided. Any damage caused to rooms, fixtures, or hotel property shall be recovered from the responsible guest(s).

#### **6. Event Arrangements & Music Policy**

All arrangements related to stage setup, décor, floral arrangements, music permissions, generators, and allied services shall be handled by the event coordinator. Outdoor music shall strictly comply with government regulations and shall conclude by 10:00 PM.

#### **7. Payment Schedule**

Payments shall be made strictly as per the agreed schedule. Full and final payment must be completed at least one (1) day prior to the check-in date.

#### **8. Cancellation, Postponement & Preponement Policy**

No refunds shall be issued under any circumstances once an advance payment has been made. However, the event dates may be postponed or preponed, subject to availability and mutual confirmation. All amounts paid shall be adjusted against the revised dates, and no cash or bank refund shall be entertained.

#### **9. Force Majeure / Government Restrictions**

In the event of postponement due to government orders, natural calamities, or force majeure situations, the advance amount may be carried forward to a future date within one (1) year from the originally scheduled event date, subject to submission of relevant supporting documents.

#### **10. Professional Conduct Clause**

Any attempt to exert pressure through threats of criminal proceedings, reputational harm, consumer complaints, or regulatory escalation shall be considered coercive and contrary to established legal principles, and may invite appropriate legal action.

## **11. Place of Jurisdiction**

All disputes arising out shall be subject to the exclusive jurisdiction of the competent courts at Goa.
